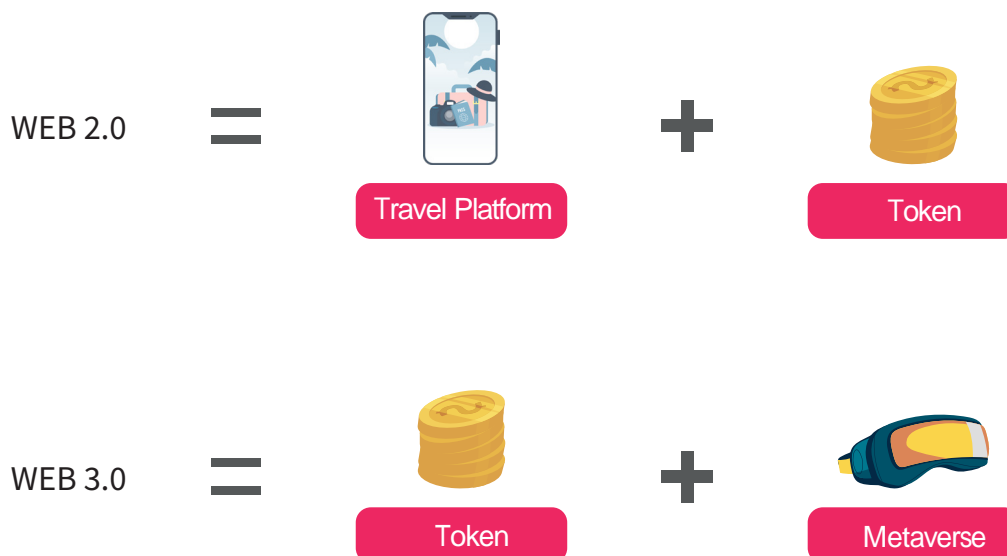
# What is Tinggle?

# Our Thoughts on Blockchain

## Belief in Blockchain

---

The two driving forces that bring about groundbreaking changes in human history are “ letters” and the other is “ money.” Through “ letters” , mankind has come to have the same awareness by translating what had previously been transmitted orally or by rote into text, making it possible to share the knowledge or imagination that was in each person’s head, which previously seemed almost impossible. The change it brought about was that we were able to develop not only subjective or externally existing objective entities as individuals, but also intersubjective concepts that could be imaginary but could be mutually sympathized, and we believed that they existed through regulations or promises, rapidly growing in number. We are now able to pursue change. Another type of “money” actually changed the world at a very rapid pace by giving use and exchange value much more easily by combining it with a writing system (including a number system) instead of the hassle of bartering, and now. In this world, currency based on promises operates as the standard of the world. Now, let’s go back and look back at the world of blockchain and cryptocurrency over the past few years. A cryptocurrency investment craze arose under the belief that it could be either an illusion or a reality that could come in the near future. This is not simply because of the concept of cryptocurrency, but also because it is the emergence of smart contracts and a new monetary value based on them as a writing system that cannot be distorted and transmitted by people since the emergence of letters to mankind, so the leaders who have encountered this They paid attention to this, and as it was about to gradually spread, I think they cheered enthusiastically as speculative sentiment among many people increased. In other words, even those who tried to solve the future by paying attention to its essence were swept up in the craze and took advantage of the craze. An environment in which many scams could emerge was created. As a result, the value has not been properly conveyed, and the craze is slowly cooling down, leaving only the image of speculation. I think I’m going through a phase right now where I need to start over.

---

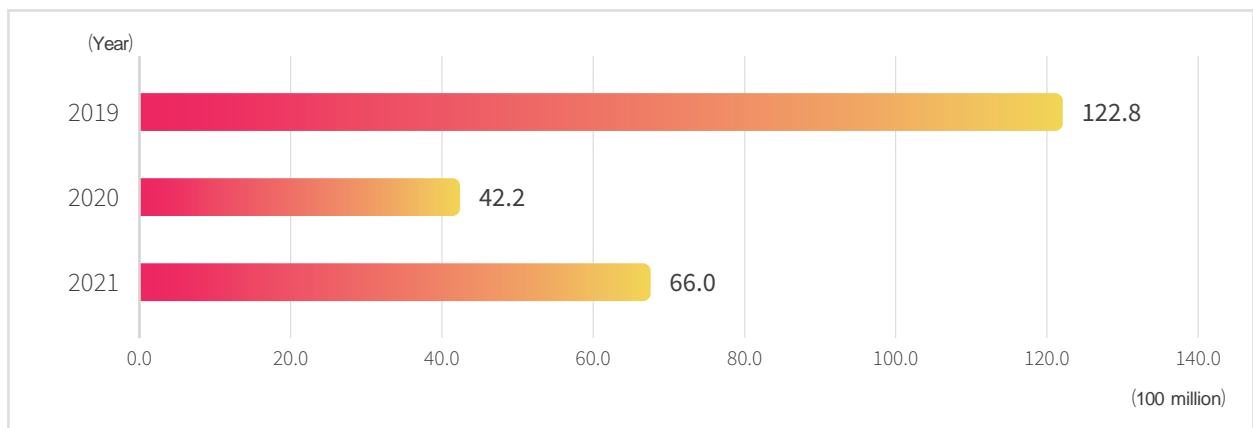
But why is it so unstable when it is a writing system that cannot be distorted and a new currency system based on it? Basically, this can be said to be because the possibility of distortion, that is, a situation that can be controlled by a few people, was recognized before its use value and exchange value were secured. In a situation where people were skeptical, claiming that investment was not decentralized, a fight broke out between Wu Ji-han and Roger Ver, who are two of the most famous people in the cryptocurrency world, regarding the Bitcoin hard fork, and people saw concentrated power, not decentralized power, and people’s perception changed. There is a fear that they could become a huge force, thereby distorting regulations and prices. As fire began to form, the phenomenon of pouring oil on the fire began to occur. I think that people who engage in such concentrated fighting are poison to the development of blockchain and cryptocurrency.

# Phenomenon and our thoughts on the travel market

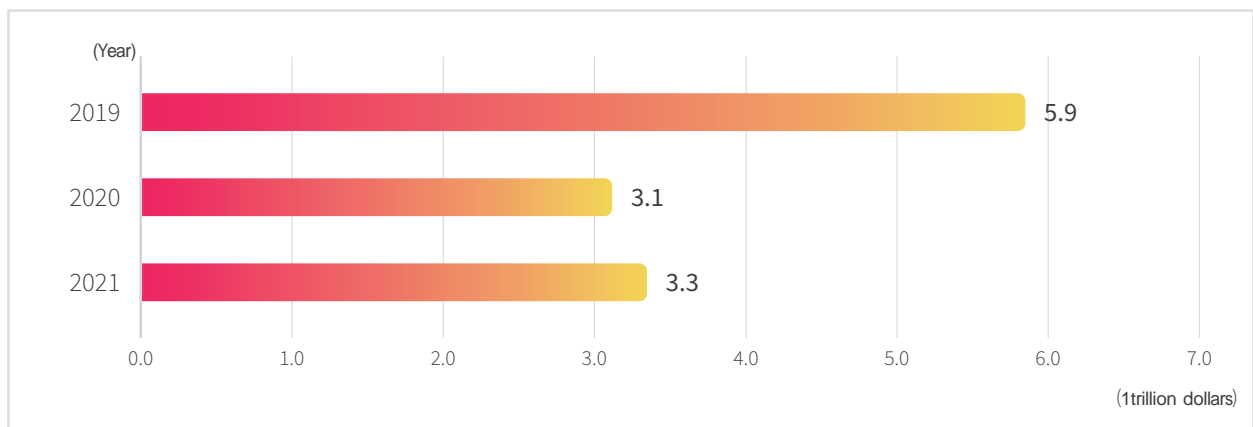
## Market size

### 1) Current status of global travel market

In 2021, global tourism has recovered to less than 60% of pre-COVID virus levels. In 2021, the number of global tourism tourists (including both domestic and international ) is 6.6 billion, and the total global tourism revenue ( domestic and international ) is \$330 billion, recovering to 53.7% and 55.9% of the pre-COVID virus 2019 levels, respectively.

## 2) Global travel market expectations

Global tourism is expected to recover by 70% compared to before COVID in 2022. The global tourism market in 2022 can be analyzed into a pessimistic scenario, a general scenario, and an optimistic scenario as follows. In the baseline situation, the number of global tourism users is 8.45 billion and the total tourism revenue is \$400 billion, which is a recovery of 68.8% and 67.8%, respectively, compared to 2019 before COVID. In a pessimistic situation, the number of global tourists will be 7.64 billion and the total tourism revenue will be 360 million dollars, which is 62.2% and 61% respectively compared to 2019 before COVID. In an optimistic situation, the number of global tourism users will reach 9.185 billion and the total tourism revenue will recover to 74.8% and 76.3%, respectively, compared to 2019 before COVID, to 450 million dollars.

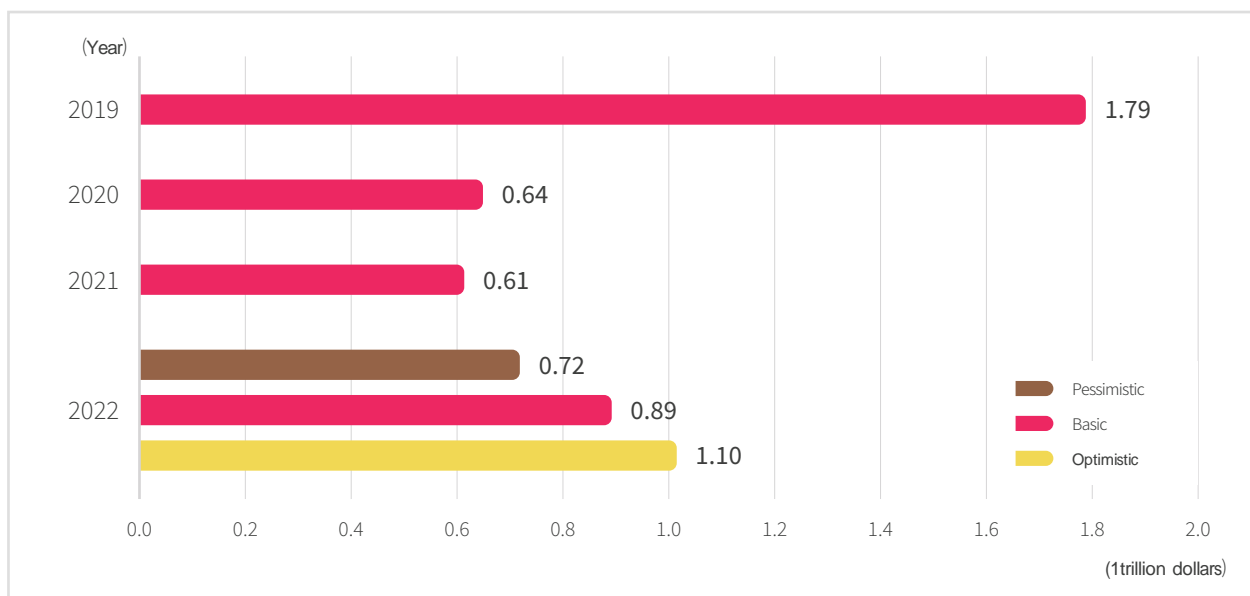
In 2022, the global tourism economy will recover to pre-COVID-19 levels (2019)

By 2022, global international tourism revenues will recover from 40% to 60% of pre-COVID levels. Total annual global international tourism in 2022

The total global international tourism revenue in 2022 is \$0.89 trillion, compared to 2019 before the pandemic. It will recover to 40-60% of provincial income. In a pessimistic situation, global international tourism revenue will reach \$0.72 trillion in 2019.

It will. In an optimistic scenario, international tourism revenues will recover to \$1.1 trillion, up 61.5% from 2019 levels.



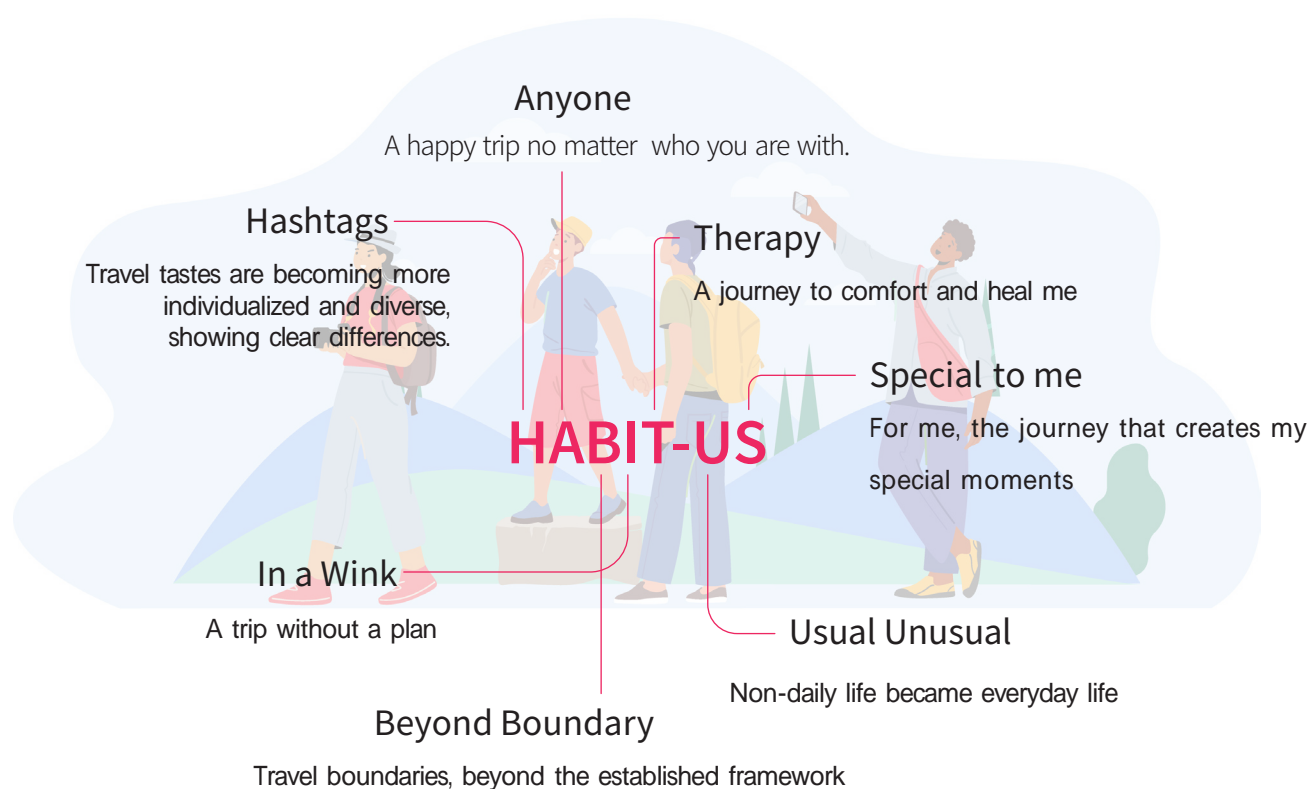

### 3) Changes in global travel trends in the post-Covid era

At the same time that there is an overall trend of deepening the gap between the two countries and increasing concentration of the tourism industry, new travel trends are also forming based on the acceleration of technology, development, and digitalization. In other words, "H.A.B.I.T-U.S.," which means experiencing and recording one's tastes through travel, is expected to be the key.

Interest in pet travel, solo travel, kids travel, etc. has also increased. In addition, frequent short-term trips in uncertain situations have become a daily routine, and impromptu travel has also emerged as a trend. Lastly, alternative travel, such as travel that comforts and heals you, online travel, and travel that allows you to experience and record your tastes are also attracting attention.



## Problems of the travel industry

---

### ① One-sided travel products that cannot satisfy diverse demands

With the Fourth Industrial Revolution, both the global travel industry and travel destinations have applied 5G and even blockchain technology to build the technical foundation and infrastructure for smart tourism. This means that all people in the world who want to travel have the hardware conditions to do the tourism they want. However, many current travel products are still provided in a structure where large travel agencies design and sell the product, then hand it over to a local land company and then provide services through local guides. This is not only a failure to apply the groundbreaking technology of the 4th Industrial Revolution to travel products, but also a failure to meet the demand of consumers who obtain information about travel destinations through the 4th Industrial Revolution and want travel products tailored to that information. . . Moreover, the travel industry ecosystem itself, formed in this way, also has major problems.

### ② Fundamental ecosystem problems in the travel industry

Problems in the travel industry ecosystem include fundamental institutional deficiencies, structural problems, dumping sales, exaggerated advertising, and poor treatment of employees, with the biggest problem being the land company problem. What is a land operator? (Land Operator) Refers to a local travel agency registered as a travel business in each country.

do. It is in charge of planning and commercializing travel products and does not directly sell travel products. For the overseas travel products in each country, travelers are recruited through large or small travel agencies in Korea, and the land agency only holds local events. Therefore, there is an increasing number of cases where companies are forced to become dependent on the tyranny of large travel agencies using the volume of travel products as bait or are incorporated into subsidiaries of large travel agencies. In the case of small travel agencies, they must embrace the risk of transactions where credit is not guaranteed, and in this process, various problems such as embezzlement and intentional default have occurred periodically, and in the end,

land companies and travel consumers who have reserved local lodging vehicles, etc. It has a structure that directly causes damage. The space for healthy

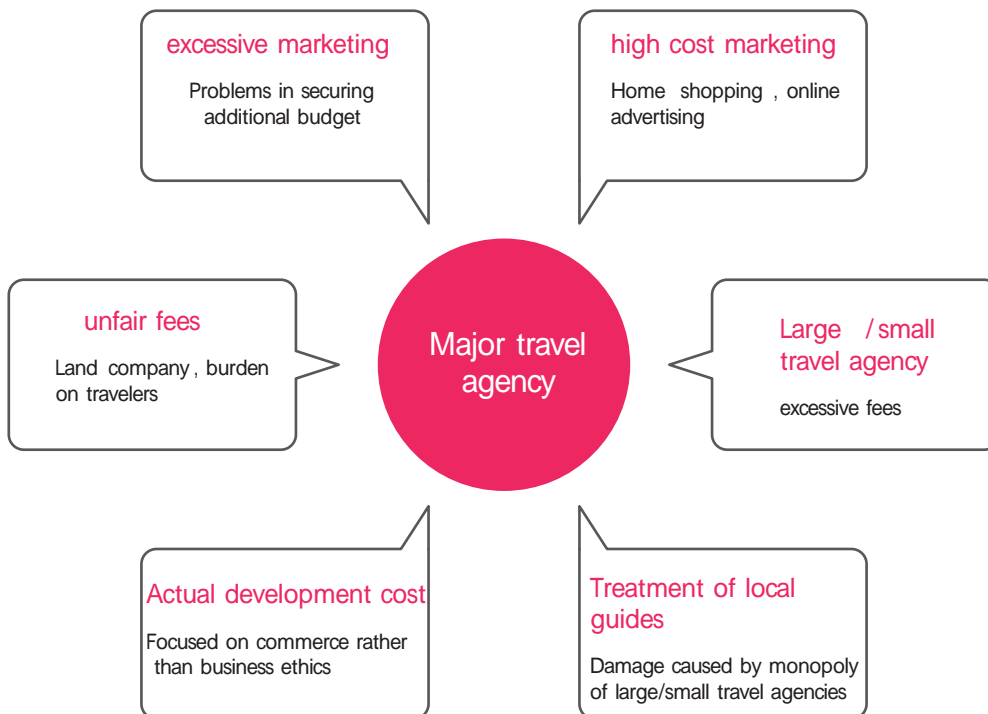
development through transparent competition among the travel industry is decreasing.

### ③ Treatment of local guides needs to be improved

Local guides are the ones who have suffered the most from the monopoly of large travel agencies. As large travel companies reorganize the travel market following the IMF crisis, the current structure of the travel industry has solidified a structure in which only large travel companies are enriched, and the income of local guides is continuously decreasing. Due to these incidents, local guides who joined the union protested against the abuse of power by large travel agencies and held rallies, but the demand for improved treatment failed to pass the National Assembly and continues to this day.

④ Profit bias and imbalance of large travel agencies

The reason for the monopoly and profit bias of large travel agencies is that most of the profits generated from travelers go to the travel agencies. However, travel products available through online advertisements are usually offered at the lowest prices, and these low-priced products have a deficit structure in which the cost cannot be covered even by the cost paid by the traveler. Land Company took on this deficit and provided local guides. Since you have to pay the cost, local shopping and options that travelers are reluctant to do are inevitably involved in order to make up for the deficit. This acts as a complaint factor that leaves only uncomfortable memories for travelers, and this vicious cycle continues to this day.

## Our offer

### 1) Token issuance and ecosystem construction will be carried out simultaneously.

The token business we are planning to conduct has significant structural and technological differences from most tokens that improve investment value through speculation. TGT is a token whose function and value are clear as part of the Tingle platform from the moment of its birth. On the Tingle platform, TGT has a clear use value, and this clear use value will allow TGT to be given a clear exchange value, and TGT that participated in building the ecosystem will be given the value of ownership and investment.

Now, decades later, we believe that blockchain is no longer a technology but a way of life and the future. ### ① We will boldly use TGT as a payment method.

The biggest problem with many current tokens and tokens is that they have no clear use. 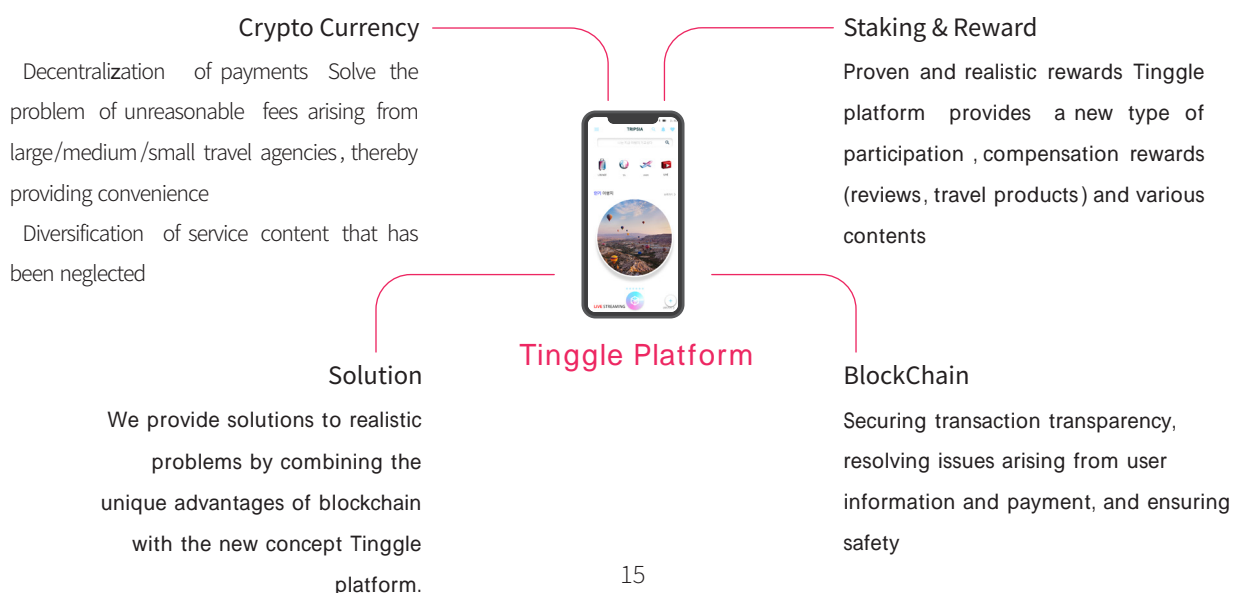

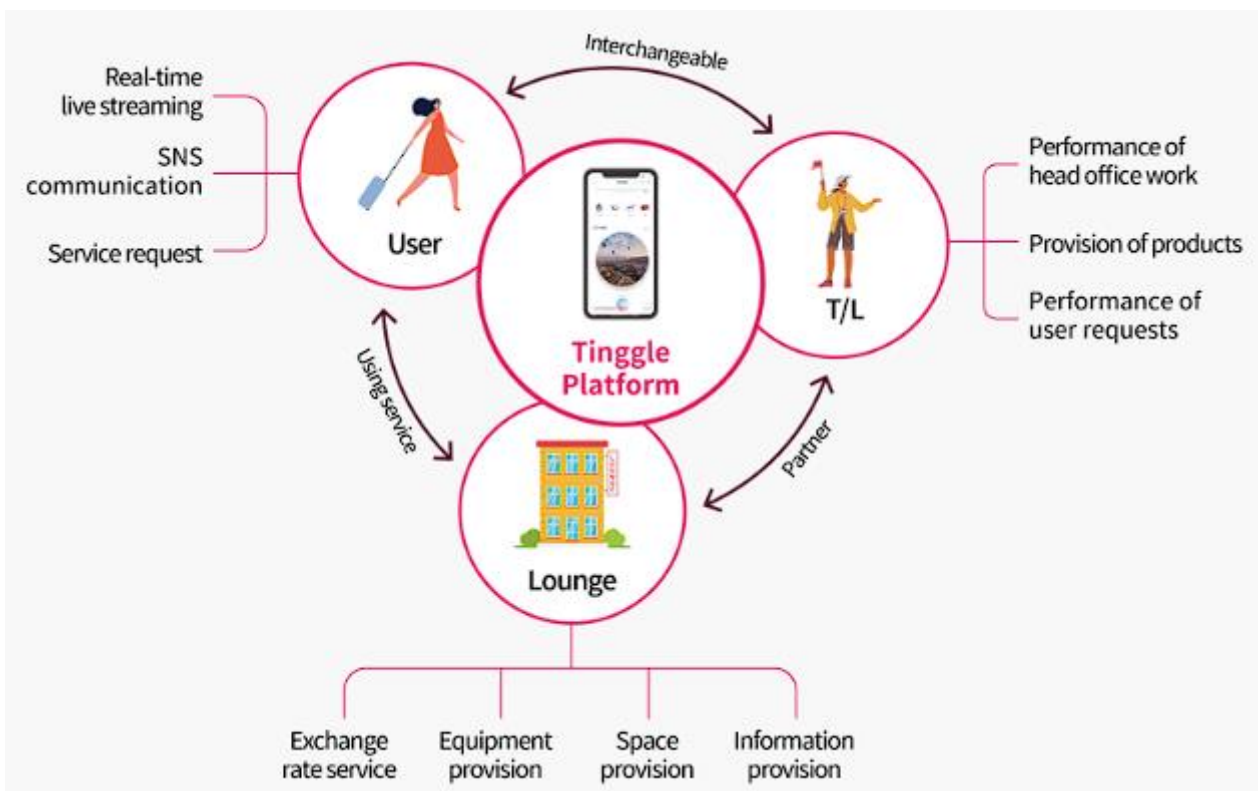

# Tingle Ecosystem

Focusing on the Tingle platform, we revitalize the Tingle token ecosystem by introducing the Tingle token as a supplementary means for users, T/L, and lounges to participate in activities on the platform.

## 1) Users

In addition to using the tokens for payments, currency exchange, and remittance on the platform, they can also be used to pay product sales fees on the platform, purchase advertisements necessary to promote one's products or services on the platform, or provide compensation to customers who purchase one's products. It is available.

## 3) Lounge

In the lounge, tokens can not only be used as a means of payment and remittance with the platform, but can also provide rewards to users and T/L as compensation for promoting the lounge, and can also be used in various ways such as product service transactions with users and T/L, and currency exchange. It can be used easily.

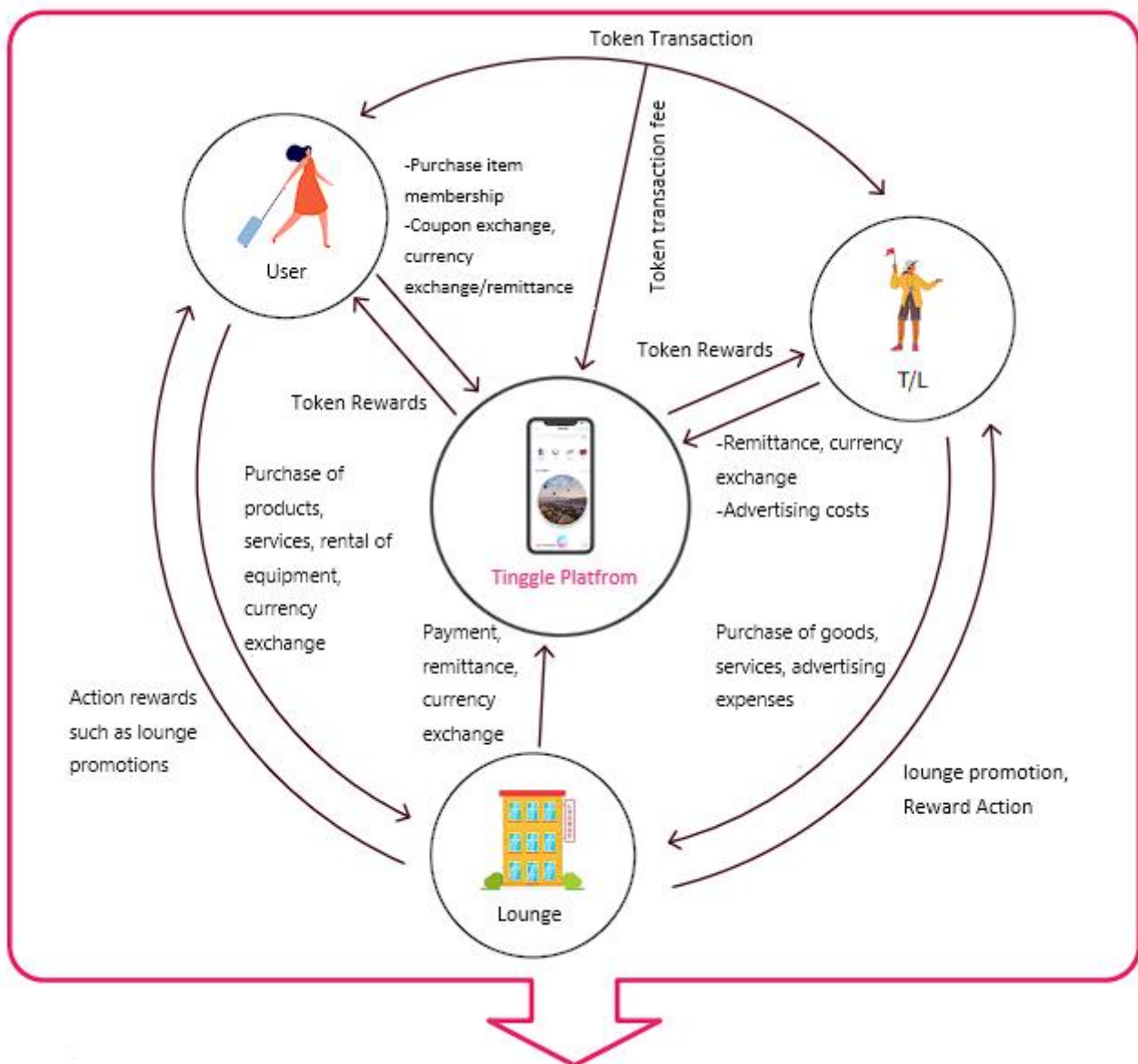
## 4) Platform

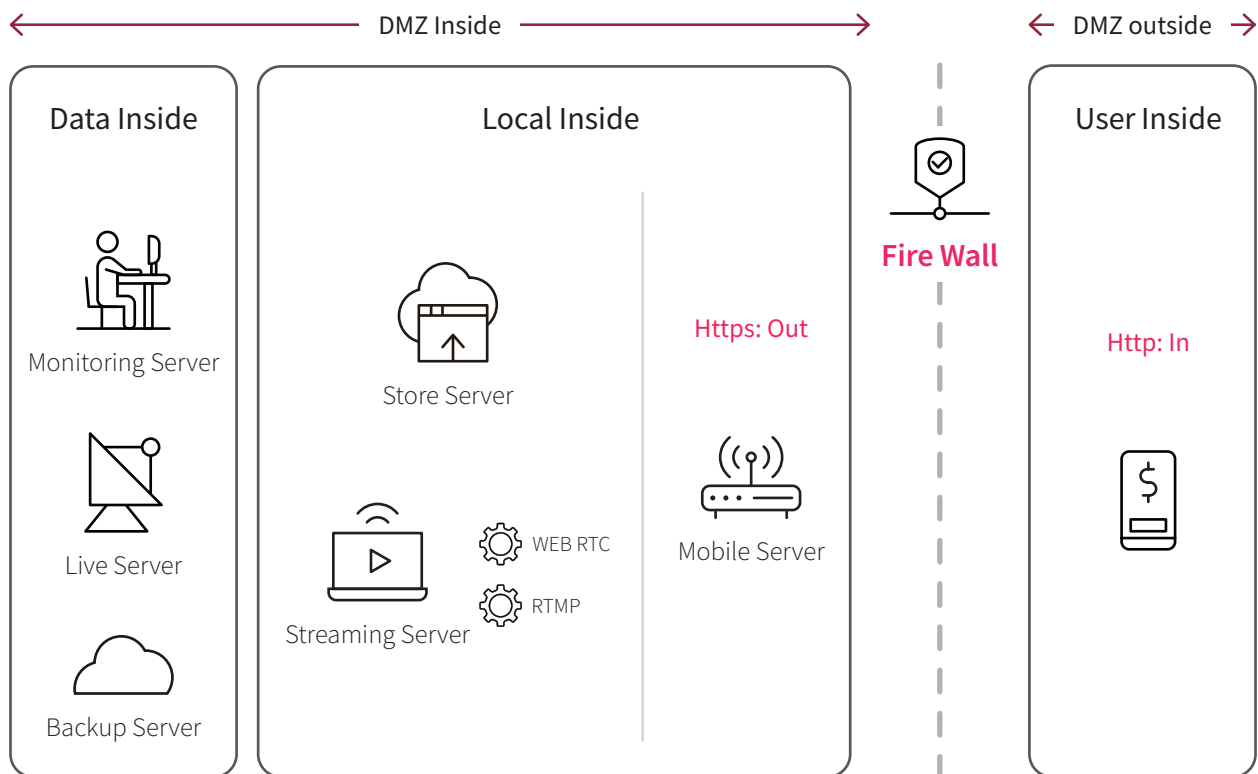
## Tinggle Wallet and Services

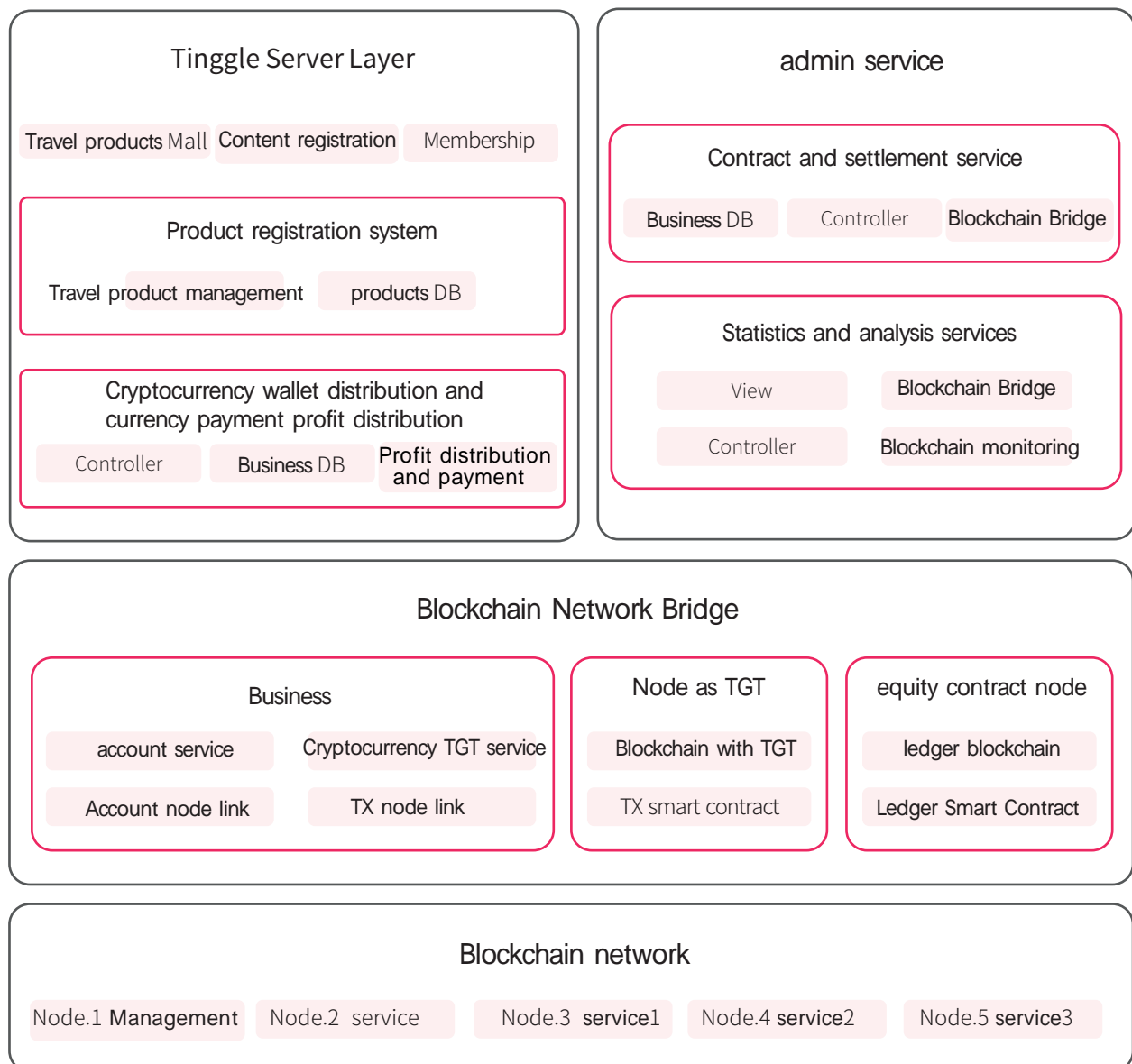
#### ► Tinggle Wallet Block Diagram



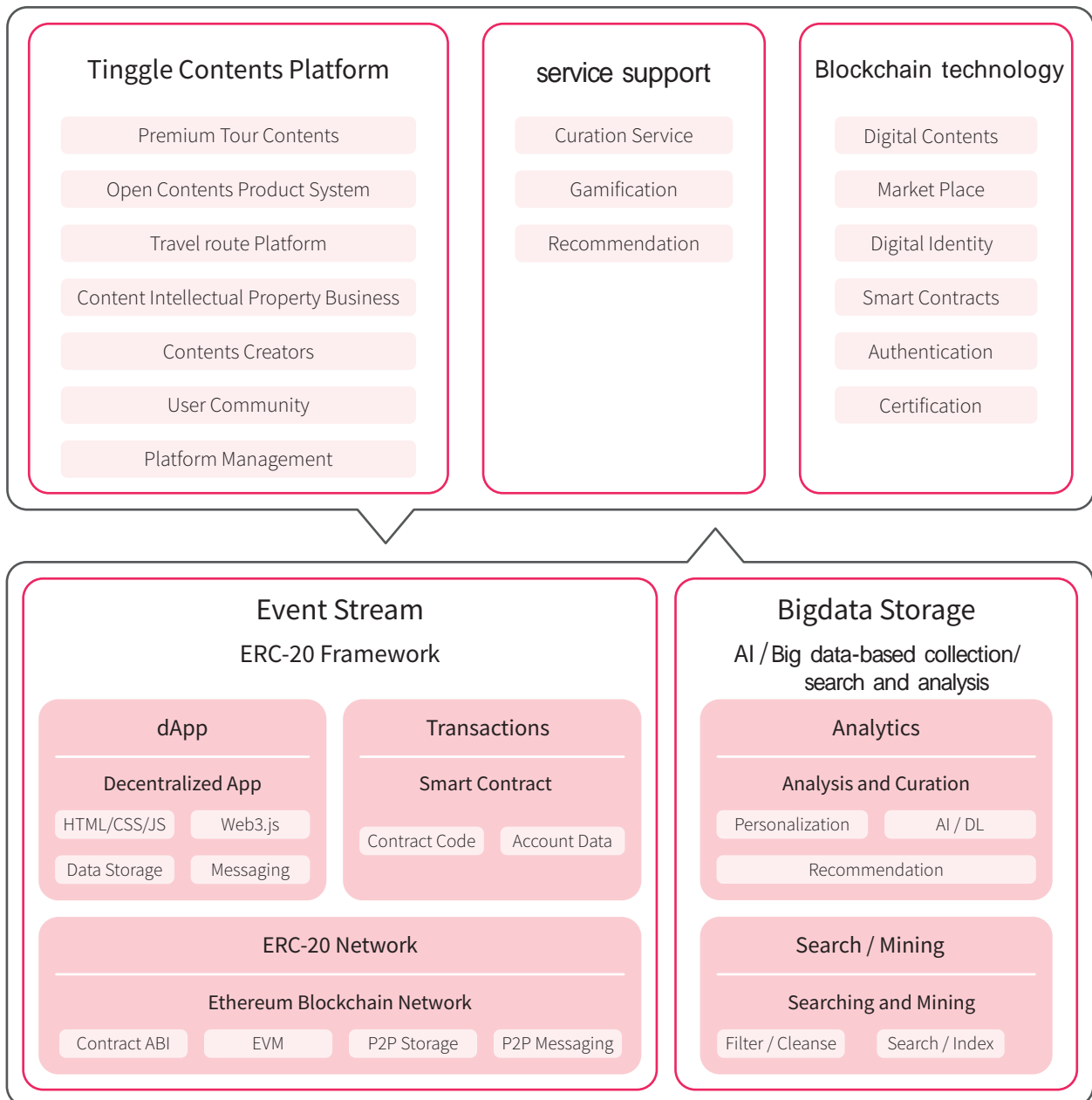
## System structure

### 1) Technical composition of the Tinggle token platform

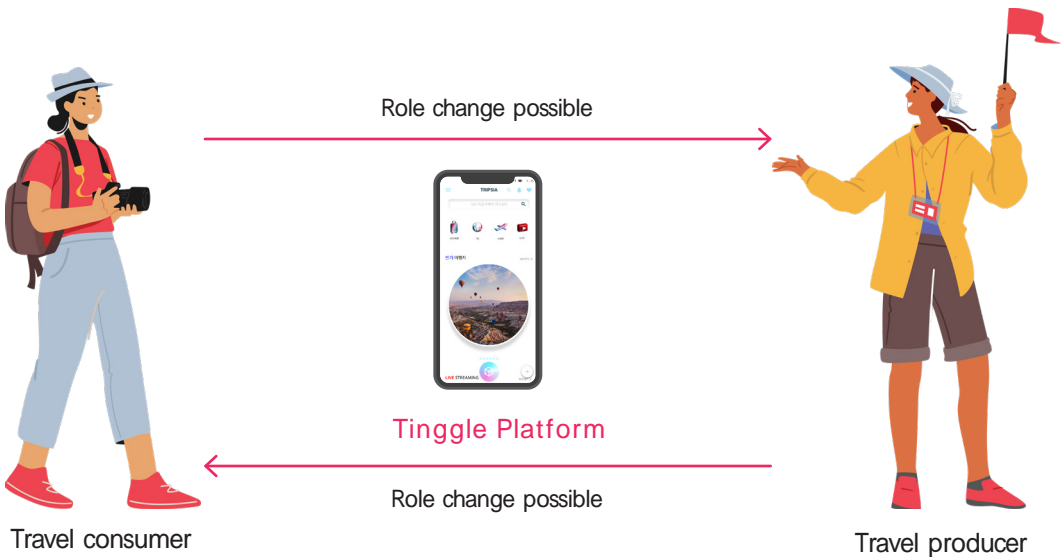
# 06. Strategy

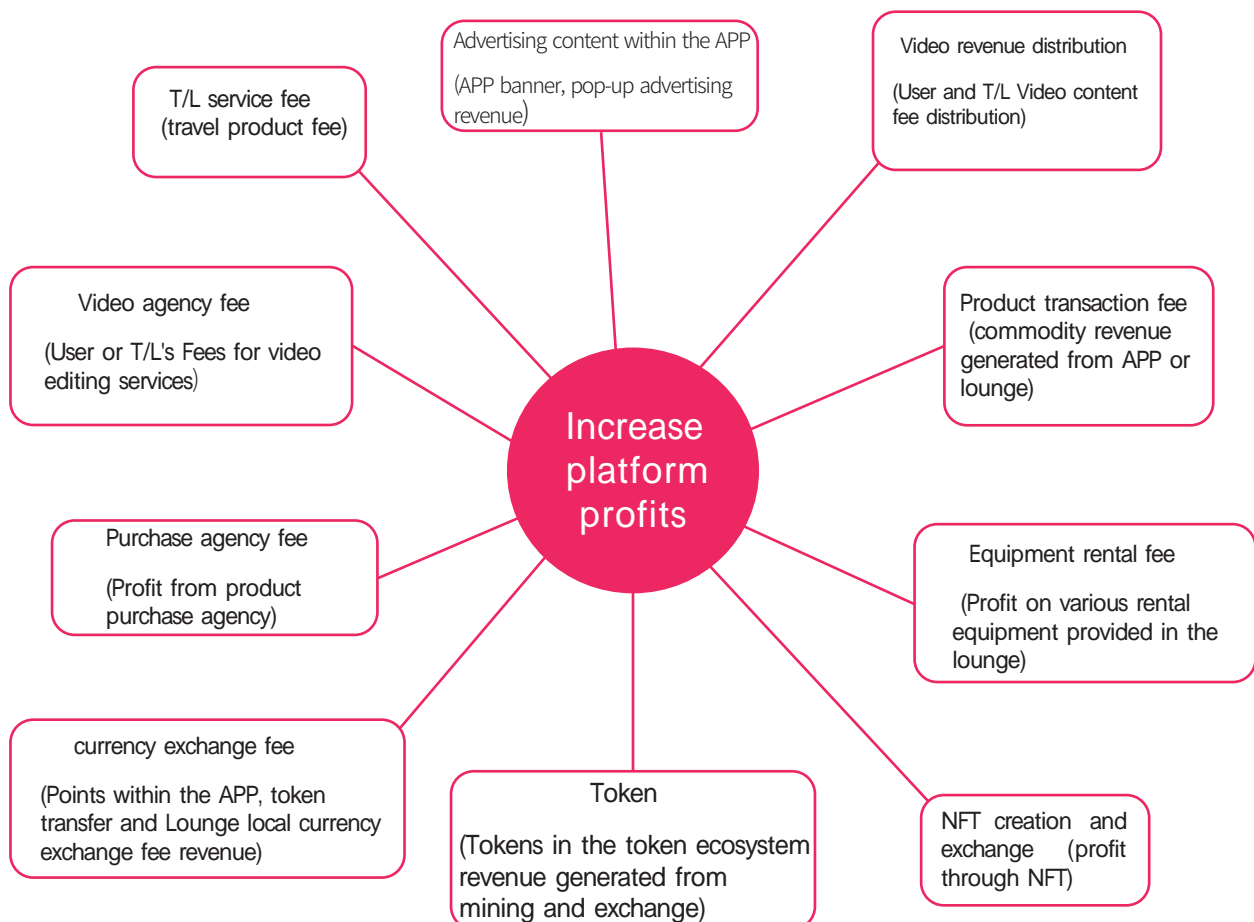

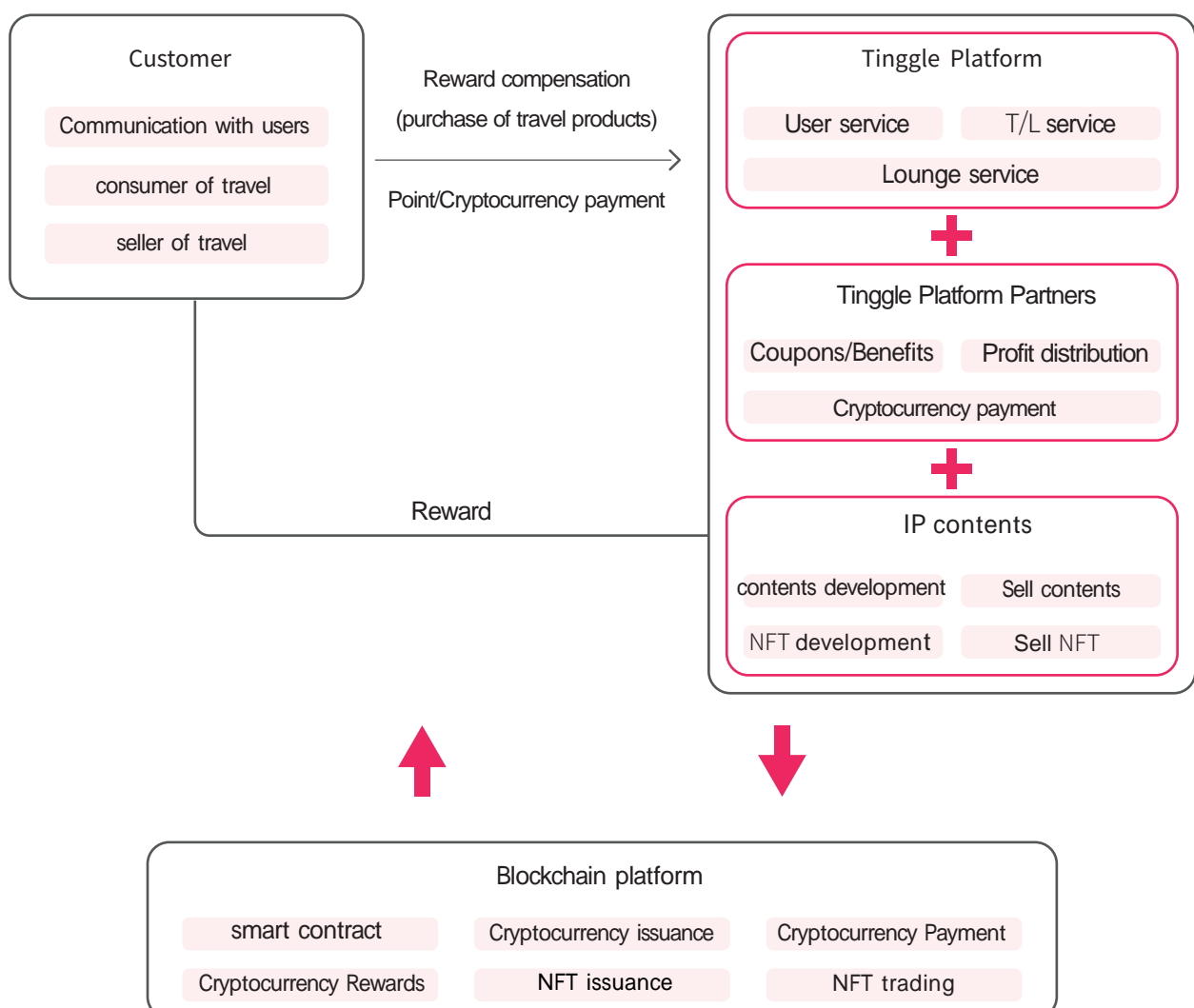

## 3) Tinggle - Building a blockchain integrated payment system

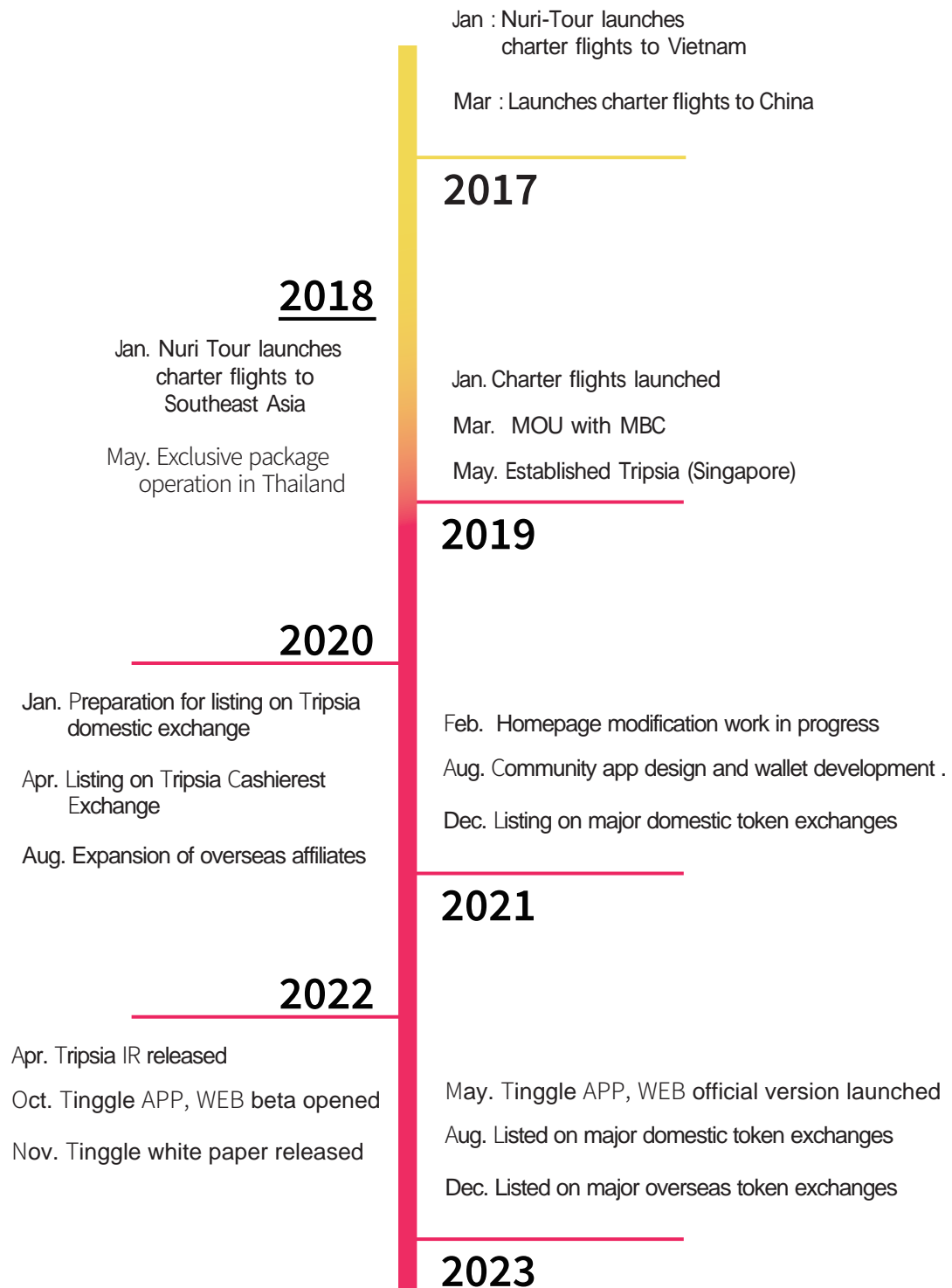

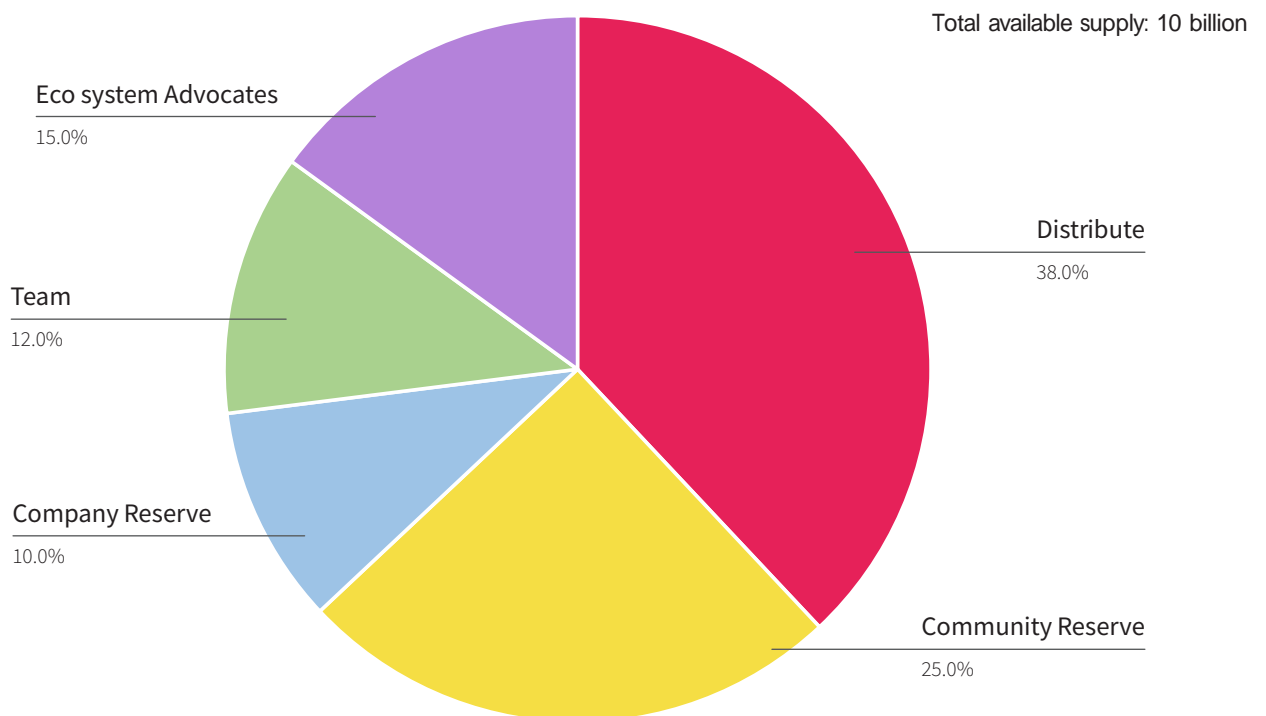

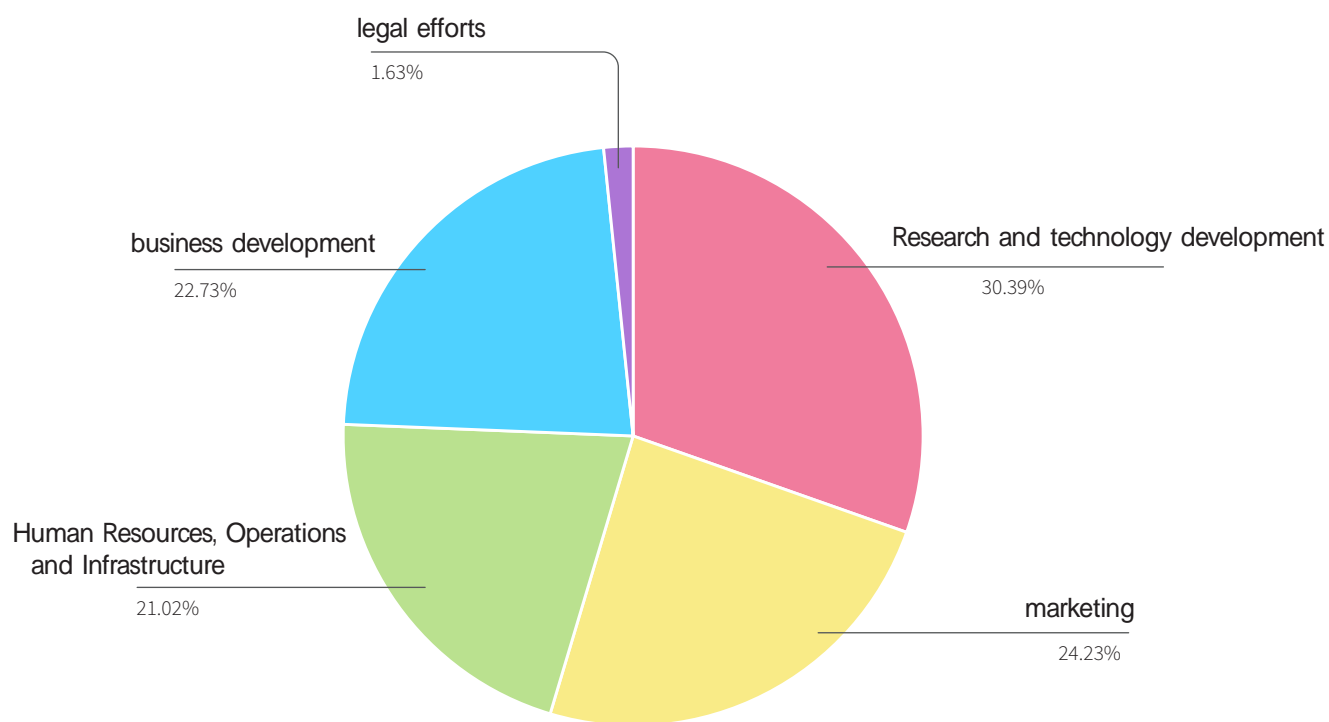

# 9. Goal
